Measuring Support for Equality in the 116th Congress





Dear Friends,

Over these last two years, Donald Trump and Mike Pence have remained relentless in their anti-equality attacks. From targeting LGBTQ people's access to health care, to supporting discrimination against LGBTQ people in the workplace, to the appointment of extreme anti-LGBTQ judges to the federal bench, this White House has redoubled their efforts to undermine our community's progress.

But the past two years have also seen critical steps towards LGBTQ equality at the federal level, thanks to the pro-equality majority in the U.S. House of Representatives. In May of 2019, the U.S. House passed the Equality Act. This is the first time a chamber of Congress has approved a comprehensive LGBTQ civil rights bill in our nation's history. The Supreme Court decision in *Bostock* this summer, affirming that sexual orientation and gender identity discrimination are prohibited under Title VII of the Civil Rights Act, was an important step forward for LGBTQ equality, but much work remains. In many aspects of the public square, LGBTQ people still lack non-discrimination protections, which is why we need to make the Equality Act the law of the land to address the significant gaps in federal civil rights laws and improve protections for everyone.

The interwoven nature of LGBTQ equality with the progress of all communities demands leadership committed to advancing justice for all. From working to increase public safety with the passage of long overdue gun background checks legislation, restoring the Voting Rights Act to ensure access at the ballot box, and guaranteeing Dreamers can stay in the only country they have ever known, pro-equality leaders in the House advanced crucial legislation for marginalized communities across the nation. And thanks to this pro-equality majority in the U.S. House, our elected champions were able to block legislation seeking to undermine our progress.

If the U.S. House has been busy working for the welfare of the American people, the U.S. Senate's tenure for the past two years has been marked by inaction and misplaced priorities. Instead of advancing pro-equality legislation, the Senate's leadership has stymied their progress. Rather, the Senate has focused on confirming as many individuals to lifetime seats on the federal bench as possible. In addition to their lack of diversity, many appointees lack the basic qualifications—as objectively assessed by the American Bar Association—to sit on the federal bench. And a great many have shown hostility to LGBTQ people.

We hope this scorecard will aid in understanding your elected officials' records on issues impacting the LGBTQ community and society's most marginalized. And we hope it is a valuable tool in holding your elected officials accountable in our shared work towards meaningful, positive change.

As the late Representative John Lewis wrote, "Democracy is not a state. It is an act, and each generation must do its part to help build what we called the Beloved Community, a nation and world society at peace with itself."

U.S. Senate

A Nomination of Amy Coney Barrett to the Supreme Court of the United States

On October 26, 2020, the Senate voted on President Trump's nomination of Amy Coney Barrett to be an Associate Justice of the Supreme Court of the United States. The Senate confirmed the nomination by a vote of 52-48 (Roll Call Vote No. 224, 2nd Session, 116th Congress). Democrats – 0 yes, 45 no, 0 not voting; Republicans – 52 yes, 1 no, 0 not voting; Independents – 0 yes, 2 no, 0 not voting. *HRC opposed the nomination*.

B Nomination of William Barr to be U.S. Attorney General

On February 14, 2019, the Senate voted on President Trump's nomination of William Barr to serve as U.S. Attorney General. The Senate confirmed his nomination by a vote of 54-45 (Roll Call Vote No. 24, 1st Session, 116th Congress). Democrats – 3 yes, 42 no, 0 not voting; Republicans – 51 yes, 1 no, 1 not voting; Independents – 0 yes, 2 no, 0 not voting. *HRC opposed the nomination*.

Nomination of Matthew Kacsmaryk to the U.S. District Court for the Northern District of Texas

On June 19, 2019, the Senate voted on President Trump's nomination of Matthew Kacsmaryk to serve as a Judge for the Northern District of Texas. The Senate confirmed the nomination by a vote of 52-46 (Roll Call Vote No. 172, 1st Session, 116th Congress). Democrats – 0 yes, 43 no, 2 not voting; Republicans – 52 yes, 1 no, 0 not voting; Independents – 0 yes, 2 no, 0 not voting. *HRC opposed the nomination*.

Nomination of Steven Menashi to the Second Circuit Court of Appeals

On November 14, 2019, the Senate voted on President Trump's nomination of Steven Menashi to serve as a Judge for the Second Circuit Court of Appeals. The Senate confirmed his nomination by a vote of 51-41 (Roll Call Vote No. 356, 1st Session, 116th Congress). Democrats – 0 yes, 39 no, 6 not voting; Republicans – 51 yes, 1 no, 1 not voting; Independents – 0 yes, 1 no, 1 not voting. HRC opposed the nomination.

E Nomination of Lawrence VanDyke to the Ninth Circuit Court of Appeals

On December 11, 2019, the Senate voted on President Trump's nomination of Lawrence VanDyke to serve as a Judge for the Ninth Circuit Court of Appeals. The Senate confirmed the nomination by a vote of 51-44 (Roll Call Vote No. 391, 1st Session, 116th Congress). Democrats – 0 yes, 42 no, 3 not voting; Republicans – 51 yes, 1 no, 1 not voting; Independents – 0 yes, 1 no, 1 not voting. *HRC opposed the nomination*.

F Nomination of Justin Walker to the D.C. Circuit Court of Appeals

On June 18, 2020, the Senate voted on President Trump's nomination of Justin Walker to serve as a Judge for the D.C. Circuit Court of Appeals. The Senate confirmed the nomination by a vote of 51-42 (Roll Call Vote No. 123, 2nd Session, 116th Congress). Democrats – 0 yes, 40 no, 5 not voting; Republicans – 51 yes, 1 no, 1 not voting; Independents – 0 yes, 1 no, 1 not voting. HRC opposed the nomination.

Nomination of Stephen Schwartz to the Court of Federal Claims

On December 8, 2020, the Senate voted on President Trump's nomination of Stephen Schwartz to serve as a Judge of the United States Court of Federal Claims. The Senate confirmed the nomination by a vote of 49-47 (Roll Call Vote No. 256, 2nd Session, 116th Congress). Democrats – 0 yes, 45 no, 1 not voting; Republicans – 49 yes, 0 no, 3 not voting; Independents – 0 yes, 2 no, 0 not voting. *HRC opposed the nomination*.

H Cloture on the Motion to Proceed to the JUSTICE Act (S. 3985)

Sen. Tim Scott (R-SC) introduced the JUSTICE Act to address law enforcement reform and accountability. However, the bill failed to provide real policing reform. The Senate rejected cloture on the motion to proceed to the bill on June 24, 2020, by a vote of 55-45 (Roll Call Vote No. 126, 2nd Session, 116th Congress). Democrats – 2 yes, 43 no, 0 not voting; Republicans – 52 yes, 1 no, 0 not voting; Independents – 1 yes, 1 no, 0 not voting. *HRC opposed cloture on the motion to proceed*.

Impeaching Donald John Trump, President of the United States, for High Crimes and Misdemeanors, Article I (H.Res. 755)

The House of Representatives passed articles of impeachment of President Donald Trump, including Article I regarding the president's abuse of power by soliciting a foreign government to interfere in the 2020 U.S. presidential election. The Senate found President Donald Trump not guilty of Article I on February 5, 2020, by a vote of 48-52 (Roll Call Vote No. 33, 2nd Session, 116th Congress). Democrats – 45 guilty, 0 not guilty, 0 not voting; Republicans – 1 guilty, 52 not guilty, 0 not voting; Independents – 2 guilty, 0 not guilty, 0 not voting. HRC urged a vote of guilty.

J Equality Act (S. 788) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on March 13, 2019, that would provide consistent and explicit non-discrimination protections for LGBTQ people across key areas of life, including employment, housing, credit, education, public spaces and services, federally funded programs, and jury service. The measure had 47 co-sponsors: Democrats 44; Republicans 1; Independents 2.

K John Lewis Voting Rights Advancement Act (S. 4263) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on July 22, 2020, that would strengthen voting rights by expanding and strengthening the government's ability to respond to voting discrimination. The measure had 48 co-sponsors: Democrats 45; Republicans 1; Independents 2.

L Do No Harm Act (S. 593) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on February 28, 2019, that would amend the Religious Freedom Restoration Act (RFRA) to exempt areas of law where RFRA has been used to bypass federal protections, including civil rights laws, thus restoring the original intent of the legislation and clarifying that RFRA is intended to protect religious freedom without allowing the infliction of harm on other people. The measure had 34 co-sponsors: Democrats 33; Republicans 0; Independents 1.

M Therapeutic Fraud Prevention Act of 2019 (S. 2008) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on June 27, 2019, that would officially classify the provision and advertising of conversion therapy in exchange for monetary compensation as fraudulent practices and expressly direct the Federal Trade Commission to protect consumers from these harmful and discredited practices. The measure had 44 co-sponsors: Democrats 42; Republicans 0; Independents 2.

N Safe Schools Improvement Act of 2019 (S. 2548) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on September 25, 2019, that would amend the Elementary and Secondary Education Act (ESEA) to require school districts in states that receive ESEA funds to adopt codes of conduct specifically prohibiting bullying and harassment, including on the basis of race, color, national origin, sex (including sexual orientation and gender identity), disability, and religion. The measure had 44 co-sponsors: Democrats 42; Republicans 0; Independents 2.

Every Child Deserves a Family Act (S. 1791) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on June 11, 2019, that would prohibit any public child welfare agency receiving federal financial assistance from discriminating against any youth involved with child welfare services or any potential foster or adoptive family on the basis of actual or perceived sexual orientation, gender identity, or marital status. The measure had 41 co-sponsors: Democrats 39; Republicans 0; Independents 2.

P FAMILY Act (S. 463) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on February 12, 2019, that would help bridge the financial gap facing many working families following the birth or adoption of a child as well as personal or family illness requiring leave from work. The measure had 37 co-sponsors: Democrats 35; Republicans 0; Independents 2.

International Human Rights Defense Act of 2019 (S. 861) (Co-Sponsorship)

Senators were asked to co-sponsor legislation introduced on March 25, 2019, that would build a framework into U.S. diplomacy to protect LGBTQ rights worldwide by making the prevention of and the response to discrimination and violence against the LGBTQ community a foreign policy priority. It would also create a Special Envoy within the State Department who would serve as principal advisor to the Secretary of State on LGBTQ issues. The measure had 41 co-sponsors: Democrats 40; Republicans 0; Independents 1.

- 1 Sen. Martha McSally was appointed in 2018 to fill the vacancy due to the death of John McCain, however, she lost the special election to fill the seat. Mark Kelly was sworn in on December 2, 2020. Because McSally was still a senator when the HRC Congressional Scorecard was originally published in October 2020, her score remains for the final publication. Mark Kelly voted against the nomination of Stephen Schwartz.
- 2 Missed the vote on the Menashi nomination but submitted a statement into the Congressional Record indicating she would have voted against confirmation.
- 3 Missed the vote on the Menashi and VanDyke nominations but submitted statements into the Congressional Record indicating he would have voted against confirmation.
- 4 Sworn in on January 6, 2020, to fill the vacancy due to the resignation of Johnny Isakson.
- 5 Sen. McConnell supported cloture on the motion to proceed to the JUSTICE Act. However, because of Senate procedure and his role as Majority Leader, he changed his vote to "no" in order to preserve the ability to bring the bill back up at a later date. McConnell is officially recorded as having voted no, but we list him as opposing HRC's position against the bill.

Schumer did co-sponsor the Equality Act, the John Lewis Voting Rights Advancement Act, the Therapeutic Fraud Prevention Act, the Safe Schools Improvement Act, the Every Child Deserves a Family Act, the FAMILY Act, and the International Human Rights Defense Act; score is based solely on votes.

U.S. House of Representatives

A Equality Act (H.R. 5)

Rep. David Cicilline (D-RI) introduced the Equality Act to provide consistent and explicit non-discrimination protections for LGBTQ people across key areas of life, including employment, housing, credit, education, public spaces and services, federally funded programs, and jury service. The House passed the bill on May 17, 2019, by a vote of 236-173 (Roll Call Vote No. 217, 1st Session, 116th Congress). Democrats – 228 yes, 0 no, 7 not voting; Republicans – 8 yes, 173 no, 16 not voting. *HRC supported the bill*.

B Speier Amendment to the FY 2020 National Defense Authorization Act (H.Amdt. 509)

Rep. Jackie Speier (D-CA) offered an amendment to the FY 2020 National Defense Authorization Act (H.R. 2500) to codify the military's existing equal employment opportunity policy to prohibit discrimination based on race, color, national origin, religion, and sex (including sexual orientation and gender identity). This would end the ban on transgender military service. The House passed the amendment on July 11, 2019, by a vote of 242-187 (Roll Call Vote No. 439, 1st Session, 116th Congress). Democrats – 232 yes, 0 no, 6 not voting; Republicans – 10 yes, 186 no, 3 not voting; Independents – 0 yes, 1 no, 0 not voting. *HRC supported the amendment*.

Cole Amendment to FY 2020 Labor, Health and Human Services, Education, Defense, State, Foreign Operations, and Energy and Water Development Appropriations Act (H.Amdt. 267)

Rep. Tom Cole (R-OK) offered an amendment to the FY 2020 Labor, Health and Human Services, Education, Defense, State, Foreign Operations, and Energy and Water Development Appropriations Act (H.R. 2740) to remove a provision in the underlying bill that would have prohibited funds to implement the Trump Administration's expansive and unnecessary regulation creating a "Division of Conscience and Religious Freedom" within the Department of Health and Human Services designed to empower health care providers to refuse service to LGBTQ people and people needing reproductive care. The House defeated the amendment on June 12, 2019, by a vote of 192-230 (Roll Call Vote No. 266, 1st Session, 116th Congress). Democrats – 3 yes, 230 no, 5 not voting; Republicans – 189 yes, 0 no, 11 not voting. *HRC opposed the amendment*.

Duncan Amendment to FY 2020 Further Continuing Appropriations Act (H.Amdt. 470)

Rep. Jeff Duncan (R-SC) offered an amendment to the FY 2020 Further Continuing Appropriations Act (H.R. 3055) to remove a provision in the underlying bill that would have codified the Department of Housing and Urban Development's guidance "Appropriate Placement for Transgender Persons in Single-Sex Emergency Shelters and Other Facilities," which provides explicit guidance and instructions for operators of emergency shelters regarding the rights of transgender beneficiaries. The House defeated the amendment on June 24, 2019,

by a vote of 181-236 (Roll Call Vote No. 401, 1st Session, 116th Congress). Democrats – 0 yes, 228 no, 10 not voting; Republicans – 181 yes, 8 no, 11 not voting. *HRC opposed the amendment*.

E Violence Against Women Reauthorization Act of 2019 (H.R. 1585)

Rep. Karen Bass (D-CA) introduced the Violence Against Women Reauthorization Act of 2019 to reauthorize critical domestic violence programs. The House passed the bill on April 4, 2019, by a vote of 263-158 (Roll Call Vote No. 156, 1st Session, 116th Congress). Democrats – 230 yes, 1 no, 3 not voting; Republicans – 33 yes, 157 no, 1 present, 6 not voting. *HRC supported the bill*.

F John R. Lewis Voting Rights Act of 2020 (H.R. 4)1

Rep. Terri Sewell (D-AL) introduced the John R. Lewis Voting Rights Act of 2020 to strengthen voting rights by expanding and strengthening the government's ability to respond to voting discrimination. The House passed the bill on December 6, 2019, by a vote of 228-187 (Roll Call Vote No. 654, 1st Session, 116th Congress). Democrats – 227 yes, 0 no, 6 not voting; Republicans – 1 yes, 186 no, 10 not voting; Independents – 0 yes, 1 no, 0 not voting. HRC supported the bill.

G American Dream and Promise Act of 2019 (H.R. 6)

Rep. Lucille Roybal-Allard (D-CA) introduced the American Dream and Promise Act of 2019 to provide Dreamers the opportunity to apply for permanent legal status and eventually become eligible for U.S. citizenship. The bill also contains protections for recipients of Temporary Protected Status and Deferred Enforced Departure. The House passed the bill on June 4, 2019, by a vote of 237-187 (Roll Call Vote No. 240, 1st Session, 116th Congress). Democrats – 230 yes, 0 no, 5 not voting; Republicans – 7 yes, 187 no, 4 not voting. *HRC supported the bill*.

H Bipartisan Background Checks Act of 2019 (H.R. 8)

Rep. Mike Thompson (D-CA) introduced the Bipartisan Background Checks Act of 2019 to require background checks for all gun purchases, not just those from licensed dealers. The House passed the bill on February 27, 2019, by a vote of 240-190 (Roll Call Vote No. 99, 1st Session, 116th Congress). Democrats – 232 yes, 2 no, 1 not voting; Republicans – 8 yes, 188 no, 1 not voting. *HRC supported the bill*.

Impeaching Donald John Trump, President of the United States, for High Crimes and Misdemeanors, Article I (H.Res. 755)
Rep. Jerrold Nadler (D-NY) introduced Article I of the impeachment of President Donald Trump regarding the president's abuse of power by soliciting a foreign government to interfere in the 2020 U.S. presidential election. The House impeached President Donald Trump on Article I on December 18, 2019, by a vote of 230-197 (Roll Call Vote No. 695, 1st Session, 116th Congress). Democrats – 229 yes, 2 no, 1 present, 1 not voting; Republicans – 0 yes, 195 no, 2 not voting; Independents – 1 yes, 0 no, 0 not voting. HRC supported impeachment.

J Do No Harm Act (H.R. 1450) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on February 28, 2019, that would amend the Religious Freedom Restoration Act (RFRA) to exempt areas of law where RFRA has been used to bypass federal protections, including civil rights laws, thus restoring the original intent of the legislation and clarifying that RFRA is intended to protect religious freedom without allowing the infliction of harm on other people. The measure had 216 co-sponsors: Democrats 216; Republicans 0; Independents 0.

K Therapeutic Fraud Prevention Act of 2019 (H.R. 3570) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on June 27, 2019, that would officially classify the provision and advertising of conversion therapy in exchange for monetary compensation as fraudulent practices and expressly direct the Federal Trade Commission to protect consumers from these harmful and discredited practices. The measure had 220 co-sponsors: Democrats 220; Republicans 0; Independents 0.

L Safe Schools Improvement Act of 2019 (H.R. 2653) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on May 9, 2019, that would amend the Elementary and Secondary Education Act (ESEA) to require school districts in states that receive ESEA funds to adopt codes of conduct specifically prohibiting bullying and harassment, including on the basis of race, color, national origin, sex, disability, sexual orientation, gender identity, and religion. The measure had 232 co-sponsors: Democrats 225; Republicans 7; Independents 0.

M Every Child Deserves a Family Act (H.R. 3114) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on June 5, 2019, that would prohibit any public child welfare agency receiving federal financial assistance from discriminating against any youth involved with child welfare services or any potential foster or adoptive family on the basis of actual or perceived sexual orientation, gender identity, or marital status. The measure had 227 co-sponsors: Democrats 226; Republicans 1; Independents 0.

N FAMILY Act (H.R. 1185) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on February 13, 2019, that would help bridge the financial gap facing many working families following the birth or adoption of a child as well as personal or family illness requiring leave from work. The measure had 220 co-sponsors: Democrats 219; Republicans 1; Independents 0.

International Human Rights Defense Act of 2019 (H.R. 1857) (Co-Sponsorship)

Representatives were asked to co-sponsor legislation introduced on March 25, 2019, that would build a framework into U.S. diplomacy to protect LGBTQ rights worldwide by making the prevention of and the response to discrimination and violence against the LGBTQ community a foreign policy priority. It would also create a Special Envoy within the State Department who would serve as principal advisor to the Secretary of State on LGBTQ issues. The measure had 215 co-sponsors: Democrats 215; Republicans 0; Independents 0.

- 1 H.R. 4 was introduced and passed by the House as the "Voting Rights Advancement Act." After the death of voting rights champion Rep. John Lewis, the House passed H.Con.Res. 107, which instructs the Clerk of the House of Representatives to change the title to the "John R. Lewis Voting Rights Act of 2020" when it is enrolled.
- 2 Rep. Paul Cook resigned his seat on December 7, 2020. Because Cook was still a representative when the HRC Congressional Scorecard was originally published in October 2020, his score remains for the final publication.
- 3 Traditionally, the Speaker of the House does not co-sponsor legislation and often does not cast a vote, however Speaker Pelosi did vote for the Equality Act, the John R. Lewis Voting Rights Act, the American Dream and Promise Act, the Bipartisan Background Checks Act, and the impeachment of Donald J. Trump; score is based solely on votes.
- 4 Missed the vote on the Equality Act but submitted a statement into the Congressional Record indicating he would have voted in favor of the bill.
- 5 Traditionally, the Minority Leader of the House does not co-sponsor legislation; score is based solely on votes.
- 6 Sworn in May 19, 2020, to fill the vacancy due to the resignation of Rep. Katie Hill; not eligible for score.
- 7 Missed the vote on the John R. Lewis Voting Rights Act but submitted a statement into the Congressional Record indicating she would have voted in favor of the bill.
- 8 Missed the vote on the John R. Lewis Voting Rights Act but submitted a statement into the Congressional Record indicating she would have voted in favor of the bill.
- 9 This seat became vacant on January 13, 2020, following the resignation of Rep. Duncan Hunter.
- 10 Missed the vote on the John R. Lewis Voting Rights Act but submitted a statement into the Congressional Record indicating he would have voted in favor of the bill.
- 11 Missed the vote on the Duncan Amendment but submitted a statement into the Congressional Record indicating she would have voted against the amendment.
- 12 Kwanza Hall was sworn in December 3, 2020, to fill the vacancy due to the death of Rep. John Lewis. Typically, Representatives who are sworn in in the last two months of a Congress do not co-sponsor legislation, although Rep. Hall did co-sponsor the FAMILY Act; not eligible for score.
- 13 This seat became vacant on October 4, 2020, following the resignation of Rep. Tom Graves.
- 14 Sworn in May 5, 2020, to fill the vacancy due to the death of Rep. Elijah Cummings; not eligible for score.
- 15 Announced he was switching parties from Republican to Independent on July 4, 2019.
- 16 Announced he was switching parties from Republican to Independent on December 14, 2020.

- 17 Missed the vote on the Equality Act but submitted a statement into the Congressional Record indicating she would have voted in favor of the bill.
- 18 Announced he was switching parties from Democrat to Republican on December 19, 2019.
- 19 Missed the vote on the Equality Act but submitted a statement into the Congressional Record indicating he would have voted in favor of the bill.
- 20 Sworn in July 21, 2020, to fill the vacancy due to the resignation of Rep. Chris Collins; not eligible for score.
- 21 Sworn in September 17, 2019, to fill the vacancy due to the death of Rep. Walter Jones; not eligible for score.
- 22 Sworn in September 17, 2019, to fill the open seat; not eligible for score.
- 23 This seat became vacant on March 30, 2020, following the resignation of Rep. Mark Meadows.
- 24 Missed the vote on the Violence Against Women Reauthorization Act but submitted a statement into the Congressional Record indicating he would have voted in favor of the bill.
- 25 Sworn in June 3, 2019, to fill the vacancy due to the resignation of Rep. Tom Marino.
- 26 This seat became vacant on May 22, 2020, following the resignation of Rep. John Ratcliffe.
- 27 Chairs of committees frequently do not co-sponsor legislation within their committee's jurisdiction. As Chair of the House Education and Labor Committee, Rep. Scott has declined to co-sponsor the Safe Schools Improvement Act.
- 28 Sworn in May 19, 2020, to fill the vacancy due to the resignation of Rep. Sean Duffy; not eligible for score.
- 29 Missed several votes; not eligible for score.
