Completing a Leader Recertification Survey

HOW IT WORKS

There are a series of summary tables in almost all criteria sections. These tables display your previous validated responses. You just need to review these tables and then affirm that your organization still has all of those policies and practices in place. If for some reason a policy or practice is no longer in place OR if you have new policies and practices in place that you would like to add, you may simply check that you would like to change your response to that question and then you will just see that particular question(s) in that section of the survey.

WHAT YOU DO HAVE TO COMPLETE

There are a few sections/items that you will have to complete:

- **Survey Contributors** let us know who has worked on the survey and who should be our primary contact.
- **Organizational Information** Most of the responses in this section will already be pre-populated based on your previous surveys please just review the information and complete any blank items.
- Criteria 1 Staff Training you will have to complete this section as well as meet your on-going training requirement. For this section, you just need to tell us that you intend to complete your on-going training requirement AND you need to upload an example of how you have promoted the HEI free training options to your patient facing staff. You do not need to have met the on-going training requirement prior to submitting the survey You have until October 31, 2023 to complete the training requirement.
- New & Revised Questions There are a number of new or revised questions in this year's survey that you will need to respond to.
- Any Questions where you change your response if you chose to change your response, you will see the question as well as any follow-up questions requesting validating information and you will be required to complete those questions and submit any requested validating information.
