RE: Americans want marriage equality protections as support continues to grow
DATE: September 2022

Nearly two-thirds (64%) of likely voters in battleground states want same-sex marriage protections to be the law of the land. Recent polling across key US Senate and Congressional battleground states shows widespread support for a law "protecting the national right to same-sex marriage" (64% support, 36% oppose)<sup>1</sup>. While majorities of men (58%) support federal marriage equality protections, the numbers are even higher among women (69%). There are no significant differences based on race and ethnicity. Majorities of Christians (55%) also support a federal law to protect marriage equality.

These numbers are in line with a national Navigator survey conducted roughly a month ago.<sup>2</sup> That poll showed 61% of the country supports "Congress passing a law protecting the federal right to same-sex marriage," with 28% in opposition and 11% unsure.

Looking at the issue more broadly, polling over the past several months shows an increase in support for marriage equality. A survey released by Gallup<sup>3</sup> released in June found that **71% of Americans support same-sex marriage, a new high-water mark**.

Increased support for marriage equality can be attributed to steady increases among most demographic subgroups of the population, including older adults and Republicans. According to Gallup, both groups provide majority support with six in 10 (60%) older voters 55+ in support of same-sex marriage and 55% of Republicans offering their support.

"Some observers of the Supreme Court's leaked draft opinion related to *Roe v. Wade* in May have questioned whether an overturning of *Roe* would clear a path for the conservative-leaning court to also overturn *Obergefell*. If this were to happen, the court would be moving in opposition to a public opinion trend that has shown increasing support."

In March 2022, PRRI found nearly identical findings with nearly seven in 10 Americans (68%) in support of allowing gay and lesbian couples to marry legally.<sup>4</sup> Roughly three-quarters of White Catholics (76%) and White mainline Protestants (74%) support marriage equality. There is also broad support in every region of the country:
