Outreach and Engagement with the Broader LGBTQ+ Community





Five Distinct Efforts of Outreach or Engagement to Broader LGBTQ+ Community (15)

Businesses must demonstrate ongoing LGBTQ+ specific engagement that extends across the firm, including at least five of the following:

- LGBTQ+ employee recruitment efforts with demonstrated reach of LGBTQ+ applicants (required documentation may include a short summary of the event or an estimation of the number of candidates reached)
- Supplier diversity program with demonstrated effort to include certified LGBTQ+ suppliers
- Marketing or advertising to LGBTQ+ consumers (e.g.: advertising with LGBTQ+ content, advertising in LGBTQ+ media or sponsoring LGBTQ+ organizations and events)
- Philanthropic support of at least one LGBTQ+ organization or event (e.g.: financial, in kind or pro bono support)
- Demonstrated public support for LGBTQ+ equality under the law through local, state or federal legislation or initiatives



Do I need one effort from each of the categories listed?

 No, your 5 efforts can come from a mix of categories or even just one of the categories. Ex. 3 marketing efforts, 1 recruiting effort and 1 philanthropic donation.

What about timing of initiatives?

- From the close of the 2022 CEI Survey(August 2021) to close of the 2023 CEI(Summer 2023).
- From survey close to survey close.
- If you included the effort on the last survey, do not include it again.
- Please give 5 unique efforts for this past period.





- Posting jobs on LGBTQ+ specific job sites/boards
- Attending LGBTQ+ recruiting events (in-person and virtual!)









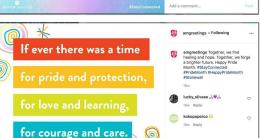






Marketing & Advertising





…it's now.



- Advertising w/ LGBTQ+ inclusive content
- Advertising in LGBTQ+ media
- Sponsoring LGBTQ+ organization and events









Philanthropic Support

Financial contributions

- Donating money to an LGBTQ+ organization or cause
- Buying a table at an LGBTQ+ gala or event

In-kind contributions

- Pro-bono work
- Volunteering
- Other in-kind gifts of goods or services















Legislative Support

Federal

- Ex. Business Coalition for the Equality Act
- Ex. Business Statement Opposing Anti-LGBTQ+ State Legislation

State

 Ex. Signing on to a letter supporting/opposing LGBTQ+ related legislation

Local

 Ex. Publicly supporting/opposing LGBTQ+ related ordinances

Judicial

• Ex. Joining an Amicus brief

THE LOOK LGBTQ+ Specific Goods/Services



Best practices:

- Consider how this products give back to the community
- Many publications produce Pride merch round ups in June.

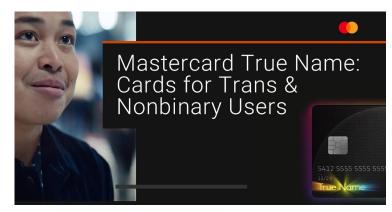
Need to be specific to the LGBTQ+ Community.

Not Eligible for Credit:

- General goods or services
- Pride or LGBTQ+ items that are only available to employees











THE LOOK Supplier Diversity w/ LGBTQ+ FORWARD Owned Businesses

Parity principle -- IF/THEN



- IF your DO NOT have a supplier diversity program, THEN you do not have to create one
- IF you have a supplier diversity program, THEN it must include LGBTQ+ owned businesses
 - A supplier diversity program that does not include LGBTQ+ owned businesses will result in a loss of 5 points (10/15)
