#### **PUBLIC POLICY CORNER**

On June 18, the U.S. Supreme Court upheld Tennessee's ban on gender-affirming care for transgender youth in United States v. Skrmetti, ruling 6–3 that the law does not violate the Constitution.

The Court applied the lowest level of judicial scrutiny—rational basis review—arguing the law is based on age and medical use, not sex. This decision narrows legal pathways for challenging similar bans and may encourage further restrictions on transgender healthcare.



#### **UPDATE ON U.S. VS SKRMETTI**

"This is going to cause many folks to consider leaving the states that they are living in," said Cathryn Oakley, HRC's Senior Legal Director. "To the extent that an employer has the ability to influence that, it is a moment for folks to be aware of, sensitive to, and responding to."

Where possible under relevant laws, employers should consider supporting impacted employees through:

- Travel and relocation benefits
- Financial assistance for legal expenses related to accessing care

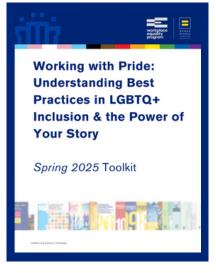
